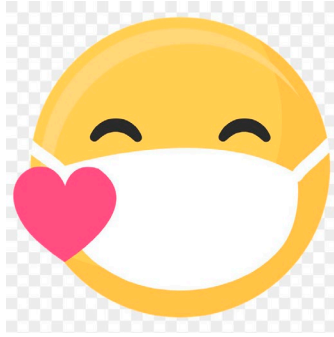

Vaccines

Vermont is using *age groupings* to determine who can receive the vaccine next based on our primary goal with vaccination efforts – *to save lives*

Vaccines

Vaccine Dashboard:

- 78,000 people have had one shot
- Even if your age group is not yet eligible, get a head start on creating an account to be vaccinated so you are ready when it's your turn to make an appointment for your first dose. Learn more at healthvermont.gov/MyVaccine
- If you have registered for testing through VDH, you are already registered.

Vermont is following the CDC's new guidance for vaccinated people who have been exposed to someone with covid-19:

The CDC says these people do not need to quarantine, as long as they:

- Are fully vaccinated (had two doses of the COVID-19 vaccine and two weeks have passed)
- Are within 3 months of receiving the second dose of the vaccine
- Have not had any COVID-19 symptoms since the exposure.

Questions & Answers on Vaccines

Question

Is it safe to breastfeed after receiving the vaccine?

Answer

There are no data on the safety of COVID-19 vaccines in people who are breastfeeding or the effects of mRNA vaccines on milk production/excretion or on the breastfed baby. mRNA vaccines are not thought to be a risk to the breastfed baby. A person who is breastfeeding and is part of a group recommended to receive a COVID-19 vaccine (for example, health care personnel) may choose to be vaccinated.

Variant Detected

Lab Results Indicate Likely Presence of COVID-19 Variant in the State

- The City of Burlington's testing of wastewater has detected the presence of two COVID-19 virus mutations that are associated with the B.1.1.7 variant, first detected in the United Kingdom. Detection of these two mutations is a strong indicator that the B.1.1.7 variant is present in the community.
- According to the CDC, studies so far show the current vaccines are largely effective against this variant. Nonetheless, health experts warn the faster spreading variants can lead to more cases of COVID-19, as well as increased hospitalizations and deaths.

People with COVID-19 in Childcare Settings While Infectious

67

people with COVID-19 were
in a childcare setting while

There are over [1,100 registered programs](#) (childcare centers, pre-K, registered in-home providers and afterschool programs) in the State of Vermont. This analysis includes people who report working or attending a childcare setting, which could include any of these types of programs.

Someone who was at childcare while infectious means there were opportunities for the virus to spread to others in the childcare setting. [Read more about the infectious period.](#)

Outbreaks in Childcare Settings



Of the over 1,100 childcare programs, there have been **6** outbreaks impacting **6** childcare settings.



This includes a total of **21** cases.



On average, there are **3.5** cases per childcare facility outbreak.

What is an outbreak in a childcare setting?

An outbreak is when there are two or more COVID-19 cases among children/students or teachers/staff with known connections in the educational setting, and the cases:

- have an illness start date or a positive test collection date within 14 days, **and**
- do not live together or have close contact with each other in another setting, **and**
- there is no other more likely source of exposure.

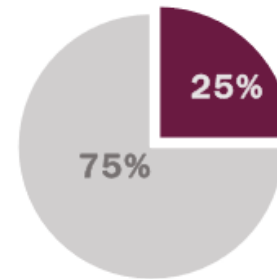

How much childcare-based transmission is occurring?

- Childcare facility-based transmission is occurring in a limited capacity, since the outbreaks are usually small and there have not been many outbreaks overall. Less than 1% of childcares in Vermont have had an outbreak.
- Transmission within childcare settings has happened too infrequently to draw any conclusion about the risk of spread.
- However, most people with COVID-19 who were at a childcare setting while infectious **do not spread to others while there (75%)**.

25% of cases present in a childcare setting were likely a result of **transmission within childcare settings**.

Recovered from COVID-19

- Governor's executive orders do not exempt people who have recovered from COVID-19 or have received a positive antibody test. This means you must quarantine when you travel or return to Vermont under the [current travel guidelines](#).
- This also means that you are not allowed to gather with people you don't live with under the [current social gathering guidelines](#).
- If you have had COVID-19 in past 3 months, and are exposed/close contact again, call us to sort out if quarantine applies or not.



Recovered from COVID-19

I have recovered from COVID-19 but I am sick with a new illness and symptoms. When can I return to work, school or childcare?

- If you develop new illness symptoms within the first 3 months of recovering from a COVID-19 infection, we do not recommend retesting. Data to date show that a person who has had and recovered from COVID-19 may have low levels of virus in their bodies for up to 3 months after diagnosis. This means that if the person who has recovered from COVID-19 is retested within 3 months of their initial infection, they may continue to have a positive test result, even though they are not spreading COVID-19.
- You should still stay home when you are sick to prevent spreading illness to others. You should remain home until your symptoms have improved or are gone. If you have a fever, you should stay home until you are fever-free (without the use of fever-reducing medicine) for at least 24 hours. Contact your health care provider if you have questions or concerns.

Algorithm – Return to Care

Cough (new)	<p>If your child has ANY ONE of these symptoms, they likely need a COVID-19 test.</p> <ul style="list-style-type: none">• Call your child's healthcare provider for medical advice and possible office visit or referral to be tested.• Communicate the plan with your child's program director or family child care provider.

Reporting a positive case

Call Health Department's COVID **School/Childcare Branch** 802-863-7240 (Mon - Fri 8 a.m. – 3pm, outside those hours, choose Option 7).

School/Childcare Branch

- Collects pertinent information, provides initial guidance on steps to take to identify and inform close contacts and quarantine as appropriate.

The situation will be assigned to **Outbreak, Prevention & Response team** for additional follow up with to assure all close contacts have been notified and all necessary public health guidance is shared, and questions are answered.

Timeline for Close Contacts of People with COVID-19



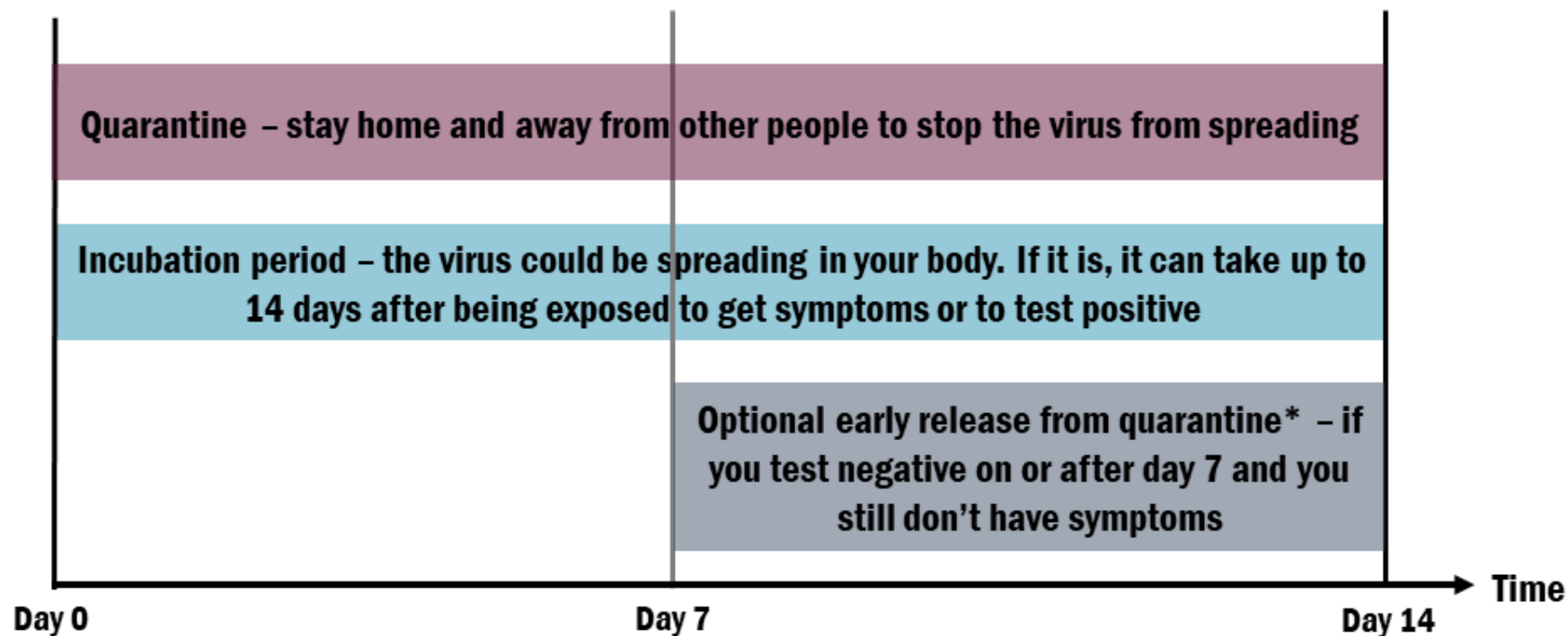
**Most recent date

Questions & Answers

Question:

Susie's cousin lives with her family and she works in NH and one of her colleagues was exposed to COVID - should Susie quarantine?

Answer: People who are exposed to people with covid during their infectious period need to quarantine. The rest of the household members who we not exposed do not have to quarantine. Entire households quarantine when the is a case in the household.



Questions & Answers

Question: When should I have a covid test?

>If you have symptoms

>If you have had known exposure

- We recommend you get tested twice — as soon as 2 days after the exposure or gathering and again 7 days after the exposure or gathering if you:
- think you have been exposed to someone with COVID-19
- are a close contact
- have gathered with people you don't live with



Questions & Answers

Question:

When will we know more about vaccine long-term infertility effects on women?

Answer:

There is no "plausible biological mechanism" by which the vaccine could affect your fertility

Question:

Once I've received the vaccine will I be able to travel without a mandated quarantine?

Answer:

Current executive order does not exclude one from quarantine when traveling if vaccinated

Governor is expected to announce new travel guidance for vaccinated Vermonter on Friday 2.19.21



Questions & Answers

Question:

If grandparents from out of town have received both vaccinations more than 2 weeks ago and come for a visit, can the grandchild attend care? What will be the protocols around those who have received both vaccinations?

Answer: Even if you are fully vaccinated:

- **You must quarantine** when you travel or return to Vermont under the [current travel guidelines](#).
- **You are not allowed to gather** with people you don't live with under the [current social gathering guidelines](#).
