#### WHAT IS A CHILD CARE SPACE?

A child care "space" refers to a place for a child in a child care program. Let's Grow Kids uses "spaces" to track the availability of child care.

Not every family needs child care for a full week, so some spaces are shared between families who use part-time child care.

# **Bennington Early Childhood Center**

#### BENNINGTON. VT

Alyson Grzyb, the director of the Bennington Early Childhood Center (BECC), and her staff, are some of the many early educators who are tirelessly and skillfully providing consistent, nurturing care to children during COVID-19.

Alyson volunteers her time to talk with community leaders and legislators about the importance of child care, and she is a leader in the early education field.

"I have been in this field for 22 years and I can't imagine doing more challenging, inspiring and important work," says Alyson.

Yet the child care system's challenges are felt deeply by both families and early educators.

"Seventy percent of the children in my program receive some form of financial assistance from Vermont, and still many of these families struggle to pay their tuition. At the same time, I struggle to pay my staff what they deserve. Many of them, including myself, have second or even third jobs to make ends meet," Alyson adds.

Providing child care during a pandemic and within a broken child care system is emotionally and financially taxing. Alyson shares what keeps her going:

"I remember the hugs and smiles from the children and the words of gratitude from the parents, and it makes me thankful to be a part of this community doing my piece to make the world right again," she says.

Thank you, Alyson and the BECC staff, for providing essential and high-quality child care services for children in your community, and for all you do to lift up the entire early education profession.

# THE CURRENT STATUS OF CHILD CARE ACCESS FOR:

### INFANTS (BIRTH TO 2 YEARS OLD)

- >> 61% of infants likely to need care don't have access to any regulated programs.
- >> 72% of infants likely to need care don't have access to high-quality (4- or 5-star) programs.

#### TODDLERS (2-3 YEARS OLD)

- >> 24% of toddlers likely to need care don't have access to any regulated programs.
- >> 45% of toddlers likely to need care don't have access to high-quality (4- or 5-star) programs.

#### PRESCHOOLERS (3-4 YEARS OLD)

- >> 25% of preschoolers likely to need care don't have access to any regulated programs.\*
- >> 40% of preschoolers likely to need care don't have access to high-quality (4- or 5-star) programs.\*
  - \*Preschool child care data does not include universal pre-K.
