



People Power

Your advocacy inspired support for increased investments in Vermont's birth-to-five child care system. In 2022...

2,679 new supporters joined Vermont's Child Care Campaign, including a coalition of 197 employers who affirmed their support of a public financing mechanism for child care and 19 early childhood educators who developed their leadership in the field as spokespeople and as peer-organizers, for a total of 38,359 campaign supporters.

Throughout the summer and fall, 24 child care programs hosted tours for candidates who ran for state offices, which brought to life how important child care is to constituents and inspired candidates to prioritize child care within their platforms. Campaign supporters were invited to organize their communities in support of child care candidates and vote for child care on election day.

Finally, in November, Vermonters elected 117 child care champions from across all parties who were endorsed by Let's Grow Kids Action Network, including 65 women and 6 people of color, which means Vermont's 2023 General Assembly contains the most women ever and the most people of color ever. Notably, Vermonters elected the first woman (and single parent) to Attorney General; the first openly LGBTQ+ person to State Treasurer; and the first woman, first openly LGBTQ+ person, and endorsed child care champion to the U.S. House of Representatives.

Policy Change

Your participation continues to influence child care policy as we transform Vermont's child care system. In 2022...

LEGISLATORS DIRECTED \$12.8 MILLION TO VERMONT'S CHILD CARE SYSTEM. INCLUDING:

- \$7,000,000 in retention bonuses for early childhood educators
- \$4,900,000 to expand the Child Care Financial Assistance Program
- \$800,000 to expand child care capacity for infants and toddlers
- \$100,000 to support high school students through the Early Childhood Education Pre-Apprenticeship Program

This essential funding continues to expand access to child care and make it more affordable for families in meaningful ways.

In preparation for the 2023-2024 legislative biennium—during which policymakers will consider full-scale child care system transformation—Let's Grow Kids partnered with families of color and families with children with specialized needs to center their experiences in our policy agenda, and to inform Vermont's future child care system. Insights from historically marginalized families with young children were also sourced via survey in partnership with community-based organizations.

Finally, our 2023 legislative agenda incorporated governance recommendations from the Vermont Child Care and Early Childhood Education Systems Analysis, as required by Act 45, and CEO Aly Richards participated in the advisory committee of the Vermont Early Care and Education Financing Study, also required by Act 45, which estimated costs, identified financing options, and assessed economic impacts.

Program Innovation

Your partnership strengthened Vermont's current child care system in preparation for forthcoming investments. In 2022...

Our multi-year efforts to increase access to quality child care continued in 2022. Let's Grow Kids awarded 88 grants totaling \$2.6 million to 82 child care programs in all 14 counties resulting in 800 new, quality child care spaces as of year-end, with hundreds of additional infant and toddler spaces anticipated in the year ahead. Notably, 8% of early childhood educators employed across all grant recipients identify as people of color.

Within efforts to grow the field of early childhood educators, including supporting 978 to enroll in preparation programs, Let's Grow Kids partnered with the University of Vermont to continue its efforts to understand and improve early childhood education preparation pathways with a focus on the experience of Black, Indigenous, and people of color studying early childhood education. Results informed the 2023 legislative agenda and provide guidance on more equitable policy for early childhood educator workforce development.

Additionally, with grant funding from the United States Department of Agriculture, Let's Grow Kids piloted child care business expansion and sustainability efforts in the Northeast Kingdom and began building capacity at regional nonprofits to support local child care expansion projects in Orange and Addison counties. Early results are promising, as are opportunities to scale these innovative models regionally.

Finally, in 2022 Let's Grow Kids continued our commitment to sharing resources and services to facilitate better business practices for the child care industry. We worked with government and nonprofit partners to establish a new, permanent child care business center to support child care programs with technical assistance and access to capital.

Financials


Thank you to the many donors who committed multi-year and one-time campaign gifts in 2022 and in years prior. Your generous philanthropy sustains campaign operations through its sunset in 2025.

The financial detail below reflects campaign revenue and expenses across both Let's Grow Kids (501c3) and Let's Grow Kids Action Network (501c4) campaign activities.

In 2022, campaign revenue totaled \$11,048,175, of which 24% was available to support Let's Grow Kids Action Network (501c4) campaign activities. In 2022, campaign expenses totaled \$7,737,599, of which 6% supported Let's Grow Kids Action Network (501c4) campaign activities.



Two Political Action Committees (PACs) were active in Vermont's November election.

- \$33,866 was raised to support the Vote Child Care Fund and all \$33,866 was expended to support Coordinated PAC activities.

 A Coordinated PAC can coordinate its activities, including the timing, content, and placement of its advertisements and paid field program, with candidates, other coordinated PACs and parties.

 Contributions from a single source are limited as are contributions made to individual candidates.
- \$32,100 was raised to support the Child Care Victory Fund and \$31,702 supported Independent Expenditure PAC activities.

 An Independent Expenditure PAC makes expenditures for communications that expressly advocate for the election or defeat of a clearly identified candidate and are not made in coordination with any candidate or their campaign or political party. Contributions from a single source are unlimited.
